

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.CoatingsHubNorCal.com, and Coatings Hub NorCal and governs data collection and usage. For the purpose of this Privacy Policy, unless otherwise noted, all references to Coatings Hub NorCal include www.CoatingsHubNorCal.com. The Coatings Hub NorCal website is a information and ecommerce site. By using the Coatings Hub NorCal website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Coatings Hub NorCal may collect personally identifiable information, such as your:
